

END USER LICENSE AGREEMENT

This **Free for Personal Use Font End User License Agreement** is a binding contract between Pendesal Studio and the individual installing the fonts, or other legal entity that the individual is working on behalf of. If you do not wish to be bound by the Agreement, you cannot access, download, or use the font.

1. DEFINITION OF TERMS

- a) “Font” is a digital product with a set of characters consisting of uppercase, lowercase, numbers, and other glyphs.
- b) “Free for Personal Use” is a type of license granted by Pendesal Studio to an individual or legal entity that permits the use of font strictly for PERSONAL USE ONLY. Commercial use of any kind, whether on a small or large scale, is strictly prohibited.
- c) “Standard License” is a type of license granted by Pendesal Studio to an individual or legal entity granting limited access to privileges for a single user only.
- d) “Extended License” is a type of license granted by Pendesal Studio to an individual or legal entity granting the same privileges as Standard License Version, but to multiple users/devices (maximum of 10 users).
- e) “Professional License” is a type of license granted by Pendesal Studio to an individual or legal entity with additional privileges such as using font to commercial publications, software, and web server, which are not included in the Standard and Extended License.

2. TERMS AND CONDITIONS

Upon downloading and installing a free version of the font by Pendesal Studio, you agreed to the following:

- a) You are allowed to embed the font into an electronic document provided that the said electronic format shall be created in a format that should not allow the font and character information to be extracted from the document.
- b) Any personal and educational use of this font is allowed.
- c) You are **NOT** allowed in any shape or form to modify, alter, convert, edit characters, or rename the font and redistribute it as your own. If you have custom request for the font, please contact the font author, Pendesal Studio.
- d) You are **NOT** allowed to share the font as a downloadable file anywhere on the internet.
- e) You are **NOT** allowed to resell, redistribute, and sub-license the font.
- f) You are **NOT** allowed to use this font to advertise your products, goods, and services. If you wish to use the font for the said purpose, you can select from the three available licensing options depending on the number of users.
- g) You are **NOT** permitted to use this font as part of your logo or to reference it within your logo design. If you wish to use the font for the said purpose, you can select from the three available licensing options depending on the number of users.
- h) You are **NOT** allowed to embed the font into commercial publications (e.g., ePub and magazine), software (e.g., games and applications), and web server. If you wish to do the aforementioned grants, you will need to select the Professional License Version. This grant is not available for Standard and Extended License Versions.

3. AMENDMENTS

Pendesal Studio may amend the Terms and Conditions in Section 2 at its own discretion and may also set forth terms and conditions that supplement this Agreement. Any amendments to the said Terms and Conditions will be reflected in the new EULA. Those individual or legal entity who downloaded the font with older version of the EULA is not subject to the terms and conditions of the amended Agreement.
